The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the period. The period we use is a month. 3) Sign up for at least four (4) of the Qualifying Products & Services listed in the table above by the end of the 150 days beginning the first day of the month immediately following the month you opened the account. 20 Basis Points are based on the Average Daily Balance on a qualifying Business account. Example: A qualifying Business account with an Average Daily Balance of \$250,000 @ 20 Basis Points equals a donation payout of \$500. All donations will be rounded up to nearest \$10. Donations for each qualifying Business Checking account will be capped at \$2,000 per client.

Your recurring direct deposit must occur by the end of the 150 days beginning the first day of the month immediately following the month you opened the account.
